# **Club Constitution Changes**

Currently the club constitution has the following section:

3 (a) Membership of the Club shall be open to all without discrimination to those who pay the appropriate fee or subscription. This fee or subscription, together with charges for the use of courts, shall be determined from time to time by a General Meeting, details of which must be given in the Agenda for that meeting. *The normal membership season shall run from 1st October and close on the following 30th September. No member may use the facilities of the Club for forty-eight hours after being accepted for membership.* 

The wording in *italics* is no longer valid:

- The adoption of the new membership system means that a membership runs annual from when a member first joins if they join after the 1<sup>st</sup> October 2019. For those members who were members before the date, the membership renewal date that has been carried over is the 1 October each year
- The forty-eight hour delay was in order for the club to have time to process payments which had been received in the form of cheques. We no longer accept cheques and membership can be granted immediately following payment of the membership fee through our membership system.

# Given the above, the committee proposes that this wording is removed from the club constitution.

Two-thirds approval of full-adult members present at the AGM is required to pass the proposal.

## PROPOSED FEES FOR 2020/2021 – No change to existing fees.

In light of the recent enforced shutdown of the club, the Committee are discussing a potential extension of members existing membership term. Further details will be given at the AGM.

The subscription includes the compulsory England Squash (ESRA) membership fees which are currently £12.50 per adult and £10.00 per junior. It is proposed to keep the subscription fees at the same level for 2020/2021.
