1. ATTENDED BY

3. MATTERS ARISING

Women's Squash Week – A squash training/playing session was held on the Monday evening which was a great event, well attended by 31 ladies.

Development fund – KWi has proposed that part of the fund is used for the following:

- Additional funding for the lower junior teams (who all came last during the previous season). Proposed for team specific training, including coaching. Committee were in favour of this proposal
- Additional funding for the ladies 2nd team who are predominantly new to the game during the last few years.
 - Court fees to be covered by the players, coaching to be covered by the programme.

<u>A – CHAIRMAN</u>

MB proposed that we put up a sponsors board including logos of all the companies who have supported the PSA tournament over the last few years.

Masters Internationals – MB proposed that we have a board recognising our Masters international players.

- JP suggested that if other members were to also have notable achievements (such as playing for their country) then this board should extend to them as well which committee agreed with. JP to draft a set of guiding principals of what achievements would make someone eligible to be on the board (based on longevity) and present back to committee.

AP proposed that there was also a board of the existing & previous Chairman's of the club to acknowledge their significant contribution to the club

At the AGM, MB discussed the charity proposal discussed at the last committee meeting which was agreed by members present at the AGM.

Squashathon to be held 11th/12th October. MB has requested members to support as they can (participate / sponsor).

Bar opening hours – extended hours licence approved from 8am to 12 noon on the 12th October for the rugby.

Cow Lane Roadworks in October 2019 - access to the car park will be maintained at all times but there will be delays and inconvenience.

Development plan on hold until end of Arnold Homes Tring Open and completion of migration to MMM. Capacity issues remain a focus.

7. OTHER REPORTS -

<u>House</u> – PIR external lighting fitting - to address safety concerns of bar volunteers locking up alone. Improved Shower lights installed. General repairs ongoing.

Following the last meeting, AP called the water company regarding the low water pressure. There were no reports regarding low water pressure in the area. In the meantime, the pressure in the showers has improved. Committee will continue to monitor the situation.

The committee room door has been found to be left open again overnight, possibly due to the fact that it can be difficult to close. MB to investigate new locking mechanisms.

8. ANY OTHER BUSINESS

AP mentioned table tennis at the club, acknowledging that it has become well supported. Currently 5 leagues of 5 people each. AP proposed that Table Tennis was added as an Agenda item to committee meetings. This was agreed, it would be covered in the minutes with only exceptions to be discussed at meetings.

There is a Bridge school taking place in the club on a Thursday afternoon for members & non-members who would like to join.

Bar prices – at the AGM, it was proposed that we could introduce higher bar prices for guests. Committee felt that it was not appropriate for the club at this stage, and would be hard from an administration perspective (the prices are displayed and they would need to be changed for every private event). Committee voted and the majority rejected the proposal at this time. This would be reviewed as/when funds are required for any development plan, or alternatively when it became easier from an administration perspective (i.e. if we ever use fobs to pay for drinks at the bar then members could get a discount on advertised prices if they paid with their fobs). Arnold Homes tournament is fast approaching and it is looking like the event will be financially even

- Ticket sales will raise £5.6k if fully sold out. Ticket sales on the day will be possible if not already sold out.
- C.£800 in incremental bar sales and BBQ
- Rose Hendin is organising stewards
- Bar needs a few more volunteers to support the rota'd barman
- Billeting still need some extra beds, please let MB know if you can offer a player a bed.
- Dave Herron is running a tournament website againwww.tringpsasquash.co.uk
- Video planning to use Facebook live again. MB to speak to MD.
- Programme is being prepared by JD
- Food for the players has organised.

Sponsorship

- MB has been approached by a company who is interested in sponsoring a court & under court clocks.
- Team sponsorship any companies sponsoring teams (for clothing etc) will be recognised with social media presence, their logo on the team page on the website, and on the newly proposed sponsors board.

Communications

- Committee felt that team captains should be promoting their own teams and should be responsible for ensuring that the fixtures lists are on the club boards, with results listed – all captains to be given access to the Tring Squash Club facebook page for social media updates.

New brushes to be bought for the courts (lots of red fluff at the moment). JW proposed that we purchase an automatic court cleaner and will send details through to MB

The ladies 2nd team had requested whether the changing rooms could be switched over on nights when the ladies teams had home matches. This was discussed but there would be issues regarding the practicalities of a switchover on any day and deemed to be difficult to communicate which may lead to privacy issues and therefore was not supported by the committee.
