4. OFFICERS' REPORTS

<u>A – CHAIRMAN</u>

David Horne has taken on the book-keeping task.

Court heating will be turned on this week.

The AGM voted to reduce the period of grace from 2 months to 1 month. The club will reduce the time before fob cut off to 7 days after the subs due date.

The club has a new laptop primarily to maintain the membership records.

<u>D – SECRETARY</u>

MB gave the committee an update of the club's welfare policy. The sub-committee needs to meet to agree the draft proposal (which has been created). Once the draft proposal is agreed this will be put to the committee for approval.
